## **My Reflections**

While watching Bro. Mark Alliance as he had the great honor and privilege of raising his son, Daniel, to the sublime degree of Master Mason, and listening to the charges and descriptions of Masonry, I could not help but reflect on my own personal experience.

It has been over twenty-two years since Wor. Bro. Dennis A. Linden bestowed the same honor and privilege upon my father, Wor. Bro. Stuart R. Wittenberg, and me. Being only twenty-one years old and a new initiate into the Masonic society, I was unable to fully appreciate how unique and special that was.

After my father's passing in 2007, I found it difficult to attend lodge meetings or events. I had never been to any lodge-related event that he wasn't at. The first meeting that I attended without him, I felt strangely out of place. I associated lodge with my father.

Growing up, I remember hearing "Dad will be home late tonight. He has a lodge meeting." I knew that both of my grandfathers and two of my uncles were "in the lodge" with my Dad. The family became even more immersed in Masonry and University Heights Lodge, as my soon to be father in-law, two brothers in-law, my brother, and cousin became brothers in our lodge. Yet still, for me the bond to lodge was my father.

My father had a great love of Masonry, our lodge in particular, and all of his brothers. Serving in the line and as Master allowed him to develop even deeper interpersonal relationships. All of you were a major part of his joy for life.

While listening to my uncle, Wor. Bro. Alan L. Wittenberg, as he spoke to Daniel, it suddenly became clear to me. I had been avoiding the very thing that needs to be embraced: brotherhood and tradition. You are my brothers and lodge is a place of solace. It is my responsibility to continue the legacy that was entrusted to me. To witness another proud and lucky father start his son on the path of light was wonderful. One day I hope that Daniel, too, can reflect upon the evening and realize the significance of that moment with his dad.

Maury was married to Bess (of blessed memory) and has two children He also has four grandchildren and four great grandchildren.

A Mason for over 50 years, Maury has developed long lasting friendships within the lodge and is most appreciative of the dignity and respect he and his wife always received. He has always enjoyed the "wonderful affairs" of the lodge.

Besides being a voracious reader, Maury loves sculpting in alabaster and has donated a number of pieces to community organizations such as the JCC, Montefiore, and Park Synagogue. He loves attending theater, film, and other social events; and has recently concluded writing his second book entitled, "Wheeling and Dealing in my World", which is already in its second printing.
